

CPD Business Meeting Minutes February 5, 2009 Royal Plaza Hotel Orlando, FL

WELCOME AND INTRODUCTIONS

Julayne Moser, Chair officially called the business meeting to order at 8:00 am.

Those in attendance were asked to introduce themselves and provide their affiliation and role (if any) within the Continuing Professional Development Division. We had 40 people at this breakfast event. The room was full.

Review and Approval of Minutes from CIEC 2008 Business Meeting

Conference Updates

Lynda Coulson prepared a detailed Program Guide for all CPDD sessions. These were distributed to each table and were also available at every CPD session throughout the conference.
