Conference Travel Stipends

ASEE / ELD Indianapolis 2014 Travel Stipends

Sponsored by

Morgan & Claypool Publishers and Momentum Press

The leadership of the Engineering Libraries Division (ELD) realizes that the American Society for Engineering Education (ASEE) annual conference is an expensive event. The <u>least</u> expensive registration for the 2014 ASEE conference is \$580. In addition, airline and hotel prices continue to increase, while at the same time university travel budgets remain the same or decrease.

While the conference costs may be particularly problematic for librarians who are new to the profession or who are in entry-level or near entry-level positions, travel support varies greatly between universities. Therefore, a librarian at any career stage may find it difficult to attend the ASEE conference.

With that in mind, Morgan & Claypool Publishers and Momentum Press have agreed to sponsor travel stipends for the Indianapolis conference. Morgan & Claypool has allocated \$1500 to be disbursed in two \$250 random drawing awards and two \$500 need-based awards. Momentum Press has allocated \$1,000 for a single need-based award.

The drawing for the two Morgan & Claypool \$250 awards was held at the ASEE 2013 Atlanta conference, with the following winners and alternates selected: Najwa Hanel and Julie Cook as winners, and Lisa Dunn, Patricia Watkins, and Deborah Helman as alternates. The award will be sent to each recipient after confirmation of the recipient's registration for the Indy conference. If a recipient does not attend Indy 2014, the funds will be awarded to the alternates in the order that they were drawn.

We are now ready to accept applications for the three need-based awards. They are as follows:

Momentum Press early career travel stipend of \$1000 – Librarians who are in their first five years of professional appointment are eligible for this.

Morgan & Claypool early career travel stipend of \$500 – Librarians who are in their first five years of professional appointment are eligible for this.

Morgan & Claypool open librarian travel stipend of \$500 – Librarians at any stage of their career are eligible for this.

Any librarian who is a <u>member of ELD as of December, 2013</u>, may apply for the travel stipend. Applicants must supply all requested information in the Web form available at <u>http://gemini.lib.purdue.edu/ELDgas/travel-appl.cfm</u>. This funding is meant to support those with the greatest need, so applicants will be asked to document what level of funding they can expect to receive from their institutions, travel information, and career information to determine eligibility.

A panel of current and / or former ELD officers will review the applications and determine the awardees. The entire pool of applicants will be listed according to need, regardless of their career stage, and awards will be granted according to eligibility. The first listed early career applicant will receive the Momentum Press \$1,000 stipend. The second listed early career applicant will receive the \$500 Morgan & Claypool stipend. The \$500 Morgan & Claypool open award will be given to the first librarian on the list who has not yet received an award.

In the event that an award recipient cannot attend, the awards will be adjusted. For instance, if the Momentum Press recipient cannot attend, then the early career Morgan & Claypool recipient will be given the \$1000 stipend, and the next early career librarian on the list will receive the \$500 award.

The travel stipend website will open on November 15, 2013. Applications MUST be received no later than 5 PM EST on **January 10, 2014**. The travel stipend panel will determine the stipend recipients, and awardees will be notified no later than January 24th.

<u>All awardees</u>, both random drawing and need based recipients, must send confirmation of ASEE registration to ELD Secretary/Treasurer Anne Rauh, <u>aerauh@syr.edu</u>, no later than **February 14th**. Checks will be sent to awardees when confirmation of conference registration has been received. <u>If registration confirmation is not received by **February 14th** the stipend will be given to the next eligible person on the list. Adherence to this timeline is necessary so that awardees and alternates will know whether they will receive awards before the ASEE conference early-bird registration deadline, which is March 30th.</u>

Awards may be used ONLY to support attendance at ASEE 2014 in Indianapolis. In the event that an ELD member is awarded a stipend and does not attend the ASEE conference, the member agrees to reimburse ELD for the stipend amount.

In the event that the travel stipends are offered in succeeding years, winners are ineligible to receive an award for two years following receipt of an award (e.g. the winner of an award for Indianapolis 2014 is ineligible for an award in Seattle 2015 and New Orleans 2016).

If you answered "Yes!" to any of these questions, please take the time and effort to nominate each item for which you said "Yes"! Please feel free to nominate more than one worthy candidate. Receiving nominations and a wide variety of perspectives is extremely helpful to the Awards Committee as it goes about trying to determine "the best of the best".

1. HOMER I. BERNHARDT DISTINGUISHED SERVICE AWARD - Each year at the ASEE Annual Conference, the Engineering Libraries Division presents an award that recognizes work that contributes to the advancement and development of excellence in engineering libraries. Membership in ASEE is not a requirement for this award.

Award nominations must include the name, title, and contact information of the nominee and nominator, nomination rationale statement, and curriculum vitae of the nominee. The rationale statement should not exceed 700 words and should clearly indicate why the candidate is being nominated for this award. Letters of support from individuals besides the person making the nomination may be included.

Deadline for Nomination: February 4, 2014.

2. BEST PUBLICATION AWARD - The purpose of this award is to honor the best new paper or non-reference monographic work in engineering information published during the year 2013.

Criteria:

1. Single or multiple authors are eligible. Works authored by Awards Committee members are ineligible during the members' term of service.

2. Work must have been published during the year prior to the year in which the award will be made.

3. Work should represent a significant contribution to the field of engineering information. Work should be scholarly, show evidence of thorough research, documentation, and critical evaluation. It should be clearly written and well organized.

3. INNOVATION IN ACCESS TO ENGINEERING INFORMATION AWARD

The purpose of this award is to honor innovation in access to engineering information.

Criteria:

1. Awarded to a person or entity for the creation of a resource, service or tool in any format that provides innovation in accessing, utilizing, or presenting engineering information. Members of the Award Committee are ineligible during the members' term of service.

2. The resource, service or tool must have become available during the two years previous to the year in which the award will be made.

3. The resource, service or tool should represent a significant contribution to the field of engineering information.

4. Resources in all media are eligible.

Deadline for Nomination: February 4, 2014.

The ELD Awards web page (http://depts.washington.edu/englib/eld/awards.php) has this detailed information on each award as well as a listing of past recipients. A new feature of the page this year highlights the work and accomplishments of the Homer I Bernhardt Distinguished Service Award winners back to 2001. We have a rich history of remarkable accomplishments by ELD members!

Remember: your participation in the nomination process is essential to keeping the Awards a vital part of ELD. Without your nominations, we run the risk of missing the "best of the best!"

ASEE ELD Accreditation & Standards Committee Update

The Accreditation & Standards Committee is undergoing a leadership change. While I have been a member of the committee for a decade, I have chaired the group for one brief year. In that time I've appreciated the work and thoughts of our talented members. I am now leaving Olin College of Engineering to become the Director of the Research Library at Los Alamos National Laboratory. Because Los Alamos is not an academic institution I must withdraw from my ASEE activities. I will greatly miss this group, but am happy to leave the committee in good hands.

Diana Wheeler, long-time member of the committee and the driving force behind our recently passed **Information Competency Standards for Engineering**, has officially been appointed our next chair. Diana is the Library Instruction Coordinator and Liaison to several departments for the College of Engineering at the University of Wisconsin -Madison. In addition to our standards, Diana has been deeply involved with our ABET work. Thank you, Diana, for stepping into this role!

Our four sub-committees are in place and moving forward. The ABET Accreditation sub-committee that I was chairing will now be chaired by Karen Vagts, who brings engineering and accreditation expertise to the group from her work at Tufts University. This sub-committee will be updating ABET member society information competency policies and notes, then completing a draft document to be shared with ABET.

The Information Competency Implementation sub-committee now has the standards posted on our web site: http://depts.washington.edu/englib/eld/committees/accreditationstandards.php and further implementation activities will continue into the new year. The Digital Learning Modules sub-committee has collected survey responses. Thanks to everyone who participated! The responses have been collated and Jan Fransen and her sub-committee will move forward with project work. The ABET Visit Form is undergoing an IRB analysis, and sub-committee members will likely receive human subjects training.


