Officer reports

3. Secretary/Treasurer – Teri Reed Rhoads – The bass account is \$85,280.08 and the operating account is at \$432.67.

Approval of minutes was seconded by Eric Soulsby and passed unanimously.

4. Vice-Chair for ASEE 2007 (Honolulu, HI, 24 – 27 June 2007) Programs – Dan Budny – approximately 200 abstracts submitted. They were reviewed and culled down to 100 with 77 papers ultimately submitted and accepted. There were a number of people who pulled out due to financing. We ended up canceling one session because so many people pulled out. We do have some conflicting sessions because ASEE would not allow us to schedule evening sessions and so we asked for additional sessions during the available hours. We also had issues with the workshops this year. There were 9 workshop proposals submitted. We recommended 7 of these as ERM workshops. Only 4 were approved by PIC chairs, and they selected which four we could offer. Attendance was down in all the workshops this year. Several session chairs were unable to attend, so all ERM members need to step up if they see no chair in a session that they are attending. There are many conflicts of session chairs with paper presentations and if they are not in our division, we can not see when other papers are scheduled. The suggestion was made that two session chairs be assigned to each session as has been done successfully in the past. This allowed for backup while letting new members partner with experienced members to assist the division. Also, some divisions sent out their proposed session chair schedule early so that the chairs could check their own schedules to check for conflicts. This also seemed to work. There was a question of whether authors could request to do a poster versus a paper session. There were multiple requests made to ASEE to update the programming capabilities. There is a current discussion to go to the full paper for initial review instead of the abstract phase. There was another issue with the Breakfast of Champions time slot and a special request by CAEE, but both issues were resolved.

Larry believes that next year will be back to business as usual with the number of workshops, For-Um and Agin-Um, and basic technical sessions and meetings.

- 13. FIE Steering Committee, Dan Moore Looking for 2011 and 2012 hosts and locations (looking for locations in the west for 2011 and 2012 for locations in the north or south). Discussions of having FIE on a cruise ship. There are discussions on Mexico, Canada and whether we want to go back to Puerto Rico. Anticipating \$18,000 going into account from FIE 2006.
- 14. National Effective Teaching Institute (NETI) Rich Felder went well but this is the first time that this did not sell out and the feedback is that it is due to Hawaii location. This is the 17th year. The attendance was 43 people and was again hosted by Rich Felder, Rebecca Brent, and Jim Stice. This location problem will help to inform future FIE decisions.
- 15. ASEE Fellows: This year six ERM members became Fellows of ASEE: Discussion was held that last year we were able to get 4 people in and this year we are up to 6 people. Comment was that we need to continue with the sponsor and nomination process currently being followed. ERM Division membership is 1,226 (2001 we had 970 members).

16. Apprentice Faculty Grant (AFG) Committee – Jennifer Karlin – We had 36 nominations which is up from 16 the prior year. The deadline was moved back into January to match ASEE registration deadlines. Pictures were gathered this year so that we can improve recognition of the recipients. One issue is the review process. With the increasing numbers, the number of reviewers needs to increase. There has been a suggestion of a system like NSF's panel session. Any suggestions are welcome. The panel session will also help with the conflict of interest issue. This year, 2 reviewers dropped out because they knew too many people. Mentors were reminded to turn in Brouhaha receipts for reimbursement. A question was posed as to how many engineers applied versus persons in engineering education. There was a discussion about the persons eligible; currently graduate students or persons moving into a tenure track faculty line, but not yet in a tenure track.

17. Distinguished Service Award Committee – Eric Soulsby, Chair
Dan Moore will receive the 2007 Distinguished Service Award.
This award will be officially presented at FIE 2007 in Milwaukee.

18. Benjamin Dasher Award Committee - Trevor Harding - stated that the talk and the paper

were excellent and if you haven't read it – you should. The selection was unanimous. Trevor has volunteered to be the chair again next year to work on the overall organization of this event. They reviewed 53 presentations. There were several last minute items that Trevor hopes to avoid this year. The guidelines have been revised but not yet approved by all committee members.

There have been questions raised on the title of the Benjamin Dasher Award winner and how professional it is (see next section). There is a discussion that there needs to be consistent response on this issue, especially since they won this award. There are currently no rules on titles. Beth Eschenbach noted that this is an actual quote and all of this was taken into account. She also would like to ask people if they read the paper. There was a paper turned down in prior years due to a word in the title and the author changed the title. Discussion of whether we would be risking censorship by creating a policy was held. There was a suggestion that we should continue with a case by case basis. Comments were made about asking the authors to consider asterisks. Also, handling these issues in the abstract stage was another suggestion.
