Professional Interest Council I Chair Report and Discussion

Christi Patton Luks (luksc@mst.edu) was introduced as the current (2019-2020) PIC I Chair. The follow topics were presented.

- ASEE meetings code of conduct
 - Work in progress to establish committees/policies/processes around the code of conduct.
 - The current handbook can be accessed here: <u>https://www.asee.org/documents/member-</u> <u>resources/resources/CodeofConductforASEEActivitiesandEvents.pdf</u>
- Conference Information
 - \circ Qty of Attendees (as of Jun 21, 2020) = 3,263
 - Qty of Published Papers = 1762 (+8 > 2019)
 - Qty of Unique Authors = 1423 (+19 > 2019)
 - Presentations will be available in "view only" for up to a year
- PIC Redistribution
 - Current PICS will dissolve prior to the Jun 29, 2020 board meeting.
 - Reorganization has been underway for more than 2 years. For example, one PIC had 12 divisions while another had 3 divisions. It didn't seem fair (e.g., best PIC award is more or less competitive depending upon your PIC).
 - Moving forward, it is proposed that the IED be re-assigned to PIC II (as requested by IED). In addition, IED will be in the same group as Engineering Economy, Engineering Management, and Systems Engineering. The PIC II chair is Chell Roberts.
- ASEE finances
 - Anticipating a shortfall of \$733K in annual conference income

- Per COVID-19, ASEE received a \$1.1 M PPP loan from the government (to cover staff salaries and rent). ASEE is unsure if this will remain as a loan or be converted to a grant.
- ASEE Membership (as of Q2)
 - Institutional (academic): -0.7%
 - Institutional (non-academic): -4.08%
 - Individual: -3%
- Bylaw Policy Change
 - All units required to have diversity, equity, and inclusion statement (DEI) in bylaws and approved no later than annual conference 2021
 - Division bylaws need to be revisited/updated every five (5) years
- BASS Accounts
 - 30% charge on BASS account income will continue to be expensed by ASEE to cover the fund management
 - Each division needs to submit spending/budget plan for the upcoming year
- IT Updates
 - Monolith replacement is underway
 - ASEE Hub is scheduled to be released July 2020
 - AMS and CMS web platforms are scheduled to be released July 2021
- BEST Overall PIC Paper
 - PIC III "Do open-ended design projects motivate first-year engineering students? By Chao Wang (Arizona State University)

On behalf of the Industrial Engineering Division, Ebisa Wollega thanked Christi for her efforts, especially with the conversation to the virtual conference.

Diversity Committee (CDEI) Delegate

- The "Committee" on DEI is now the "Commission" on DEI. This provides a different strategic position within ASEE.
- ASEE and SEFI (European Society for Engineering Education) developed a joint DEI statement.
- CDEI created a Constituent Award. Eligibility includes ASEE divisions, councils, zones, regions, committees, and ad hoc groups (not individuals).
- 18 nominations were submitted for the Best DEI Paper this year.
- CDEI has published new tips/guidelines for the DEI Paper Award. Check out their updated website for additional details.

Raymond Smith III provided a draft call for papers. The focus is on "Entrepreneurship and Industrial Engineering."

Installation of New Officers
