2020 ASEE Conference IED Business Meeting Summary

Twenty-nine members attended the annual IED annual business meeting, which was conducted virtually. Topics discussed include ASEE code of conduct, bylaws, affiliated divisions, conference attendance, finance, and IED papers statistics.

The Professional Interest Council 1 (PIC I) Chair, Christi Patton Luks, reported several changes. First, the <u>current handbook</u> for the ASEE meetings code of conduct is under re-development to establish committees, policies, processes. Second, all current PICs will dissolve as of the Jun 29, 2020 board meeting and be redistributed. Moving forward, the IED be re-assigned to PIC II (as requested by IED), which is the same PIC group as Engineering Economy, Engineering Management, and Systems Engineering. The PIC II chair is Chell Roberts. Third, there is a new bylaw policy change whereby all units are required to have diversity, equity, and inclusion statement (DEI) in bylaws and approved no later than annual conference 2021. Thereafter, the division bylaws need to be revisited/updated every five years. Fourth, BASS accounts will continue to be charged 30% by ASEE administration to cover the fund management. Each division needs to submit spending/budget plan for the upcoming year. Finally, with respect to information systems, Monolith's replacement is underway. The ASEE Hub is scheduled to be released July 2020 and the AMS and CMS web platforms are scheduled to be released July 2021.

The ASEE annual conference attendance was 3263, the quantity of published papers was 1762 (+8 > 2019), and the quantity of unique authors was 1423 (+19 > 2019). As of 2020 Q2, individual ASEE membership is down 3%, institutional non-academic membership is down 4.08%, and institutional academic membership is down 0.7%.

The IED program chair, Ebisa Wollega, presented the following IED conference papers statistics comparing the current year to the past four years. Overall, the number of abstracts submitted in 2020 increased while the number of papers published in 2020 declined.
