

MINUTES OF THE  
THIRTY-THIRD ANNUAL MEETING  
OF THE SOUTHEASTERN SECTION  
of the  
AMERICAN SOCIETY FOR ENGINEERING EDUCATION

April 12, 13, 14, 1967

The thirty-third annual meeting of the Southeastern Section of the American Society for Engineering Education was held on April 12, 13, 14, in Huntsville, Alabama, with the University of Alabama at Huntsville serving as hosts. The published list of registrants indicated an attendance of 260 men, of which 30 represented industry. There were 54 ladies present.

Mayor Glenn Hearn and H. Clyde Reeves, Vice President, University of Alabama at Huntsville, welcomed the group to Huntsville in brief addresses at the opening session.

At the Annual Banquet, Deans Charles Weaver and Ralph Fadum presented the third Western Electric Awards for Outstanding Teaching to Ele Eugene Stansbury of the University of Tennessee, and to Henry Dittimus Bowen of North Carolina State University. J. F. Thorpe presented the annual Award of the Research Unit for Outstanding Contribution to Research to Dr. Oscar W. Dillon of the University of Kentucky for his paper "Waves in Bars of Mechanically Unstable Materials."

The annual business meeting convened at 11:45 A.M., April 14, 1967.

The minutes of the previous meeting and the Treasurer's Report, which had been distributed to the members, were approved.

President Bennett announced that the approximate attendance at this meeting was 314, including the wives. He also mentioned the addition of the Venezuela Branch and the new Technical Institute Division.

Otis Lancaster, Vice President for Sections East, brought greetings from the National Organization. He mentioned several topics which had been discussed at the National or Sections East Level. Among these were: the admission of the Venezuela Branch, the approval of the dues increase, need for increased activity at the Local level and schools, and seminars on improvement of teaching. He also spoke of the possibility of the return of one dollar of dues to local sections or schools for proper usage to improve engineering education. He also praised the holding of meetings on Thursday and Friday, and mentioned that the Council had passed a resolution to cooperate with engineering Technology schools. In conclusion, he spoke of the need for critical review of articles to be published in the Journal.

Professor B. L. Baker, Chairman of the Resolutions Committee, read the report of the committee. Resolutions thanking those who contributed to the success of the meeting were adopted by a unanimous vote.

Professor C. P. Marion, Chairman of the Place of Meeting Committee, reported that an invitation had been received and accepted for the 1969 meeting. The committee recommended that the Section continue to establish meeting places for two years in advance. The report was adopted by unanimous vote.

The places for the next two meetings are:

1968 - Blacksburg, Virginia Hosted by Virginia Polytechnic Institute.

1969 - Miami, Florida, Hosted by University of Miami.

President Bennett presented the recommendations of the Constitution and Bylaws Committee.

The recommendation, which follows, was to Change Article II - Membership, Section 6, to read:

The Section shall cover an area designated by the National Society and presently including Alabama, Florida, Georgia, Kentucky, Mississippi, North Carolina, South Carolina, Tennessee, Virginia, the Commonwealth of Puerto Rico, and any Latin American and South American countries, including the West Indies Islands, having within their boundaries an authorized branch of ASEE.

The recommendation was adopted by a unanimous vote.

Professor W. R. McIntosh, Chairman of the Nominating Committee, presented the following nominations for officers of the Southeastern Section for the coming year:

Secretary-Treasurer - L. K. Himelright, The Citadel.

It was moved that the slate be elected by acclamation. The motion was seconded, and passed unanimously.

There being no further business, the meeting adjourned at 1:05 P.M.
