THIRTY-FIFTH ANNUAL MEETING OF THE SOUTHEASTERN SECTION of the

AMERICAN SOCIETY FOR ENGINEERING EDUCATION

April 16, 17, 18, 1969

The thirty-fifth annual meeting of the Southeastern Section of the American Society for Engineering Education was held on April 16, 17, 18, in Miami Beach, Florida, with the University of Miami serving as host.
