Chair Gonzalez called the meeting to order on Tuesday, June 28, 2016 at 7:11 p.m. in room 213 of the New Orleans Convention Center, New Orleans, Louisiana.

1. Greetings and Introductions

2. Reports

a. Secretary's Report

Barbara Bernal circulated the minutes from the 2015 annual business meeting in Seattle, Washington. These were approved, with minor changes, on a motion by Rob Hasker.

b. Treasurer's Report

Rob Hasker reported that the BASS account had a balance of \$3,441.02 as of December 2015 and that the operating account has a balance of \$125.

c. Division Chair's Report

Fernando Gonzalez discussed the workshop to have been presented by Jim Valino. Conference coordinators accepted the workshop, but it was later canceled when SwECC leadership determined that there was strong overlap with another workshop.

d. Program Chair's Report

Barbara Bernal circulated a report for the 2016 conference:

- 26 abstracts were submitted, 1 rejected
- 18 draft papers were submitted and reviewed (with 6 past the deadline)
- 12 finalized papers were submitted and accepted
- There were 62 reviewers

The list of sessions and published papers are in Appendix A.

Several program-related issues were discussed. Some members suggested holding a panel discussion, with one recommendation based on the software competency model and another on continuous delivery of software. There was also a suggestion for doing a panel with the Systems Engineering Division.

e. PIC II Report

Barbara Bernal discussed issues that came up during the PIC II meeting. Rob Hasker and Barbara Bernal represented SwECC at the meeting. SwECC was reported as having 192 members in June with over 200 by the start of the conference. Rob Hasker asked the PIC II chair, Marjan Eggermont, what was needed to become a full division. M. Eggermont responded that the criteria had been met and that she would bring a motion to the board of directors. There was additional discussion about the process for collecting and reviewing papers.

3. Business

a. There was discussion about the ASEE's response to ABET. SwECC members expressed concern about the process of generating a response from ASEE. The town hall meeting was disorganized, as was the response itself.

The meeting adjourned at 8:13 p.m. with an invitation to attend an informal dinner.
