Ronke’s email of July 9 presented the group’s finding to the membership.

Hearty congratulations to our division award winners! Malaica Oxnam is our well deserved recipient of the Homer I. Bernhardt award for her many contributions to our profession, most notably the TRAIL Project. Jacob Carlson, Michael Fosmire, C.C. Miller and Megan Sapp Nelson shared the Best Publication Award for their article “[“Determining Data Information Literacy Needs: A Study of Students and Research Faculty”](#). *portal: Libraries and the Academy*, 11 (2):629-657, April 2011. Well done all!

As to the remainder of the program, I would like to thank all our moderators and speakers for their participation. Our moderators, Anne Rauh, Karen Vagts, Pauline Melgoza, Mel DeSart, Angie Locknar, Susan Boyd and Ted Baldwin did a fine job of smoothly running our sessions. A few highlights of the program included an “unconference” panel discussion entitled, “Value, Impact and Performance - We know we are VIPs but how to measure and demonstrate it?” organized by Dianne Mizzy, and our first remote guest speaker in a panel discussion on mobile technologies.

A late addition to the program, the unconference session provided a stimulating group conversation on assessing and presenting demonstrable value of services that Engineering Librarians provide. At our mobile technology session, we enjoyed a presentation by Jason Casden, Digital Technologies Development Librarian at NC State and [Library Journal “2011 Mover and Shaker”](#), delivered from the comfort of his own desk in Raleigh, NC. Thanks to Susan Boyd and Jason for successfully pulling that off and paving the way for possibly more presentations like this in the future.

One disappointment this year with the conference, and discussed at the Extended Executive Committee, was the lack of any ELD posters presented this year. There are a variety of reasons for this, but chief among them, we believe, is ASEE’s “publish to present” requirement. Based on EEC discussion, Adriana Popescu, our Program Chair for the 2013 Annual Conference in Atlanta, has taken steps to encourage more “Works in Progress” papers that may be presented as posters rather than presented in technical sessions. Please make note of her call for abstracts and be sure to get them in by the posted deadline!

Another cause for concern is the increase in registration and publication fees for Atlanta implemented by ASEE. According to our PIC IV Chair, Bev Watford, ASEE has been operating under a deficit for the past several years and has undertaken an effort to improve its revenue stream. Higher membership dues and associated conference fees have been one result. Bev forwarded on to ASEE concerns I expressed to her about this and how it may affect ELD attendance at future conferences. While no immediate relief is forthcoming, she did send me a [written rationale](#) for the increases.

Regardless, planning is taking place for Atlanta with Adriana Popescu at the helm. Please be alert not only to her call for papers, but also for opportunities to volunteer as they arise. One of the things I admire most about ELD is that its members always rise to the occasion when called upon. I would expect that to continue in Atlanta.

One last post-conference item that I’d like to report is the Accreditation and Standards Committee’s efforts to promote revisions to the ABET criteria on information literacy. Dianne Mizzy received an invitation to attend part of the annual ABET meeting in July to answer questions about the ELD proposal and received generally positive feedback.

Danianne has informed that the proposal is currently being folded into the entire revision process for Criterion 3 and that the A&S Committee has formed a subgroup to provide summary information for this effort. Many thanks to her for these endeavors.

Approval of 2011 EEC Minutes – A. Van Epps moved; M. White Seconded

Conference review –

Received good feedback courtesy of Mel

The program chair/new officer orientation was problematic, and our concerns will be forwarded to the ASEE administration.

New ideas met with success

- remote speaker (sound levels need to be accounted for next time)
- SWOT team
- mixer turned out well
- Every session room had enough seats (added chairs Monday)  
ASEE accommodated moving rooms for one session (the conference attendance was down 10-15 people from normal)

Major concerns:

Number of papers submitted/no posters were submitted at all.

Amy would like to survey membership to find out why people aren't submitting papers/posters.

Potential reasons for falling interest:

Many administrators don't see ASEE/ELD as an advancement society; do survey of administrators to determine how ASEE is perceived

Suggested course of action: post-conference survey

Do a survey of the membership regarding barriers to paper submission

Do a random survey of administrators of ELD members (library deans) to understand perception problems

**Action Item:** Amy will do quantitative analysis of previous ASEE conferences regarding the number of posters/publications submitted.

Note: ASEE will automatically assign sessions based on past two years of historical data and submissions this year.

Was there too much food this year? Other potential methods of sponsorship:

- Workshops funded instead of food;
- Homer Bernhardt award with travel stipend/ lodging or a stipend.  
There are concerns about ASEE hoops to make monetary awards possible.  
The awards committee will investigate adding a monetary award for the Homer Bernhardt award.
- Can sponsorships be used to pay submission fee?  
**Action Item:** Amy will contact Graduate Student Division to find out their guidelines for poster submission – “reviewed posters” don't have a submission fee.

The mobile schedule was a great addition that we would like to see continue to the future.

Online feedback form – M. White found it very convenient. We should put the URL on the programs ahead of the conference next time; (ASEE let us know about the online forms on Sunday).

### Development report:

Handling sponsor requests for marketing opportunities (providing lists of attendees, etc.)

- ASEE ELD needs a written agreement for each sponsor completed by December that spells out what the sponsor can reasonably expect from ASEE
- ASEE changed their policy dramatically regarding handing out participant lists – vendors no longer have an automatically generated list of participants.  
Elsevier requested a list of conference attendees last year as well as this year.  
Vendors can pay for membership in ASEE to access membership directory.
- Sponsors want to brand events; recognition at beginning of session as well as in the business meeting.
- Whether vendor marketing literature can be present at conference events is different between ACRL STS and ASEE ELD
- Development handles contingencies that arise; executive committee confirms agreement with development decisions
- Want to hand out marketing policies to vendors
- Policies need to be rewritten with change in opt out policies  
We potentially have 14 vendors for next year  
Vendors will leave early on Tuesday in Atlanta  
Vendors want more time in vendor hall, but ASEE has shortened available window of time  
Can't anticipate vendor questions ahead of time

**Action Item:** Larry will revise vendor guidelines for development liaisons to approach vendors for fall

**Action Item:** Doug will request a list of conference participants from Patty

Currently, we are dependent upon banquet registration or a doodle pull on ELD-L to determine conference attendance ahead of time.

### Bylaws update:

Amy entered the Preamble to Committee and Appointed position descriptions and template for committee descriptions/charges for approval.

- The committee has developed models for committee descriptions
- Committee chairs/ officers – produce current, accurate description based on template  
**Action item:** deadline agreement - July 31<sup>st</sup>, 2012
- How will it be submitted? Google docs – committee will share with committee chairs
- EC will approve descriptions; can be presented to membership for input  
**Action Item:** Amy – send out reminder to ECC list after conference
- Taskforces: Executive Committee and/or chair can designate taskforces;
- Standing committees have documentation in bylaws; taskforces do not have documentation/publications
- Are task forces a part of the EEC?
- Appointed positions are Extended Executive Committee for the duration of the task force. Please deposit documents in archives at end of taskforce/committee.

### Update on ABET initiative:

- Currently the ASEE/ABET committee is deliberating on the ELD proposal;
- The term “engineering research” was removed from the criteria going forward  
( not all programs do research for undergraduates)
- The proposal may be sent back for changes or adopted with language struck out
- The proposal will go to the Criteria committee in July 2012 or in July 2013

### Need for ELD-L and ELDNET-L policy for ILL/doc delivery requests:

- Individuals who are misusing the list-servs need to be addressed directly.  
**Action Item:** Mel will send out message clarifying that they may ask if someone has a copy of an item, but not to ask for the item directly.
- Mel and Craig will refuse inappropriate requests to users based upon a policy.
- Paige moved that the ELD listserv committee draft a common subject line for holdings information requests.  
Information requests should be limited to which institutions own the item.

- Mel suggested coming up with criteria and common subject line language before implementing a new listserv specifically for materials requests.
- Larry seconded Paige's motion.
- Annie suggested a friendly amendment: Moderators will reject requests for copies. Messages that specifically ask for photocopies will be returned to authors for revision. EEC will approve and enact policy. This group will review the policy periodically.
- Motion with friendly amendments carried.
- 

### 2013 conference planning:

- Willie Baer and Lisha Li (both of Georgia) will serve on conference planning committee.
- Adriana will issue a call for volunteers to ELD.
- Suggestions for sessions:
  - Biomedical engineering information workshop
  - Liberal arts combined suggestions
  - Open Access session with a Scholarly Communication panel : Potentially a distinguished lecture Specific interest was in the topic of intersection on Information Literacy and scholarly communication
- The development committee will decide how the directors handle the events for this year.
- Committees need a method for rotating out members and reconstitution. The EEC will consider dismissing all committee members and bringing select members back or chairs will have discretion to take measures as needed.
- Do we need a second time block for EEC for next year? We could use the email group to follow up if the agenda does not get fully covered.

## ELD Business Meeting Minutes

Michael White called meeting to order at 9am. His introductory remarks acknowledged INSPEC's and Knovel's sponsorship. Also, there were thanks expressed to Doug McGee for his work as the Program Chair. Mike also thanked all ELD members for giving him the opportunity to serve the division and acknowledged all members of EEC and all chairs that came before: Jay, Amy, Bob, for their help and support. As past chair he will start talking to people about serving in the next term.

PIC IV Chair Bev Watford was introduced. She then asked P.K. Imbrie to provide the updates from the Board Meeting:

- PIC IV consists of 13 divisions.

- We are going to see increase in dues

- Multiple options for membership types will be available

- Registration for conference is under discussion to increase

- Session evaluations – no longer done by ASEE – it was a cost saving measure – we will have to do our own

- Best paper process – nominations sought for people to sit on a committee to review papers

- ASEE no longer organized a picnic; a mixer event was introduced and feedback is encouraged

- PIC special funding grants are available to help promote the division. Fund needs to be matched by the division. 6 divisions were awarded grants to develop promotional materials, fund a special speaker. The maximum award is \$500 and the division has to match the award amount from its own funds.

- Changes in paper submission requirement: each presenter must be associated with a full registration

In response to the updates and comments made by Bev and P.K., several suggestions and comments were made by ELD members:

- The requirement to publish papers for posters is killing the poster sessions. It is proposed to review abstracts only.

- Graduate Students Division has a mechanism in place to submit a poster for review rather than a paper.

- Keep registration open while the reception and mixer are under way on Sunday.

- Cap registration fees at current levels.

Michael White called the business meeting to order with the approval of last year's meeting minutes.

- Reminder about the Banquet to be held at Iron Works located on River Walk.

Treasurer – June update available upon request.

Archivist – Two ELD historic documents are posted to the ELD web site.

Accreditation and Standards Committee – Dianne Mizzy reported about an ABET criteria revision proposal to add one criterion to student outcomes and a minor revision to criteria 7. Thanks were extended to all A&S committee members who worked on this project. The proposal is on the agenda to be discussed by the ASEE Accreditation Activities Committee. Hopefully, the proposal will be taken under consideration and placed on the agenda at the next ABET Commission meeting, to be held July 19-22. Future work for the ELD A&S Committee will seek to establish a registry of members who went through accreditation, a post ABET visit survey and encourage members to share documents relevant to ABET accreditation process. Thanks were extended to Megan Sapp Nelson for her work on STS Information Literacy standards.

# Call for Papers

I hope you are all now settled in the routine of the new academic year, so you may find some time to consider submitting an abstract for ASEE 2013 in Atlanta. The deadline for the abstract submission is Monday Sept. 24th by 5pm.

I would like to point out that a submission can be made either as a full paper or as a Work-in-Progress paper. The criterion for a full paper is that it represents, at the time of draft paper submission, work that is complete, containing actual results for peer review. Work-in-Progress submissions are for reporting on work that is still in the process of study and/or implementation for which results will not be available by the time of draft paper submission; abstracts and papers submitted in this category must have titles beginning with the phrase, "Work-in-Progress: *Title*." Work-in-Progress submissions are normally presented as posters, but they can also be assigned to a technical session. ASEE maintains a paper requirement for posters, and like all papers submitted, the Work-in-Progress papers will be reviewed and evaluated based on the content relevancy and quality, not on the quantity. Should a Work-in Progress be completed and reported as a complete work at the time of draft paper submission, the paper will be included in a technical session. I am happy to answer any specific questions you may have about submitting works in progress ([popescua@princeton.edu](mailto:popescua@princeton.edu)) and if you are wondering what a Work-in-Progress paper looks like, take a look at AC 2011-2036 available at [http://www.asee.org/file\\_server/papers/.../ASEE\\_Davis\\_w\\_revisions.pdf](http://www.asee.org/file_server/papers/.../ASEE_Davis_w_revisions.pdf).

If you're interested in submitting an abstract, PLEASE REVIEW the information in the Author's Kit located at [http://www.asee.org/conferences-and-events/conferences/annual-conference/2013/program-schedule/2013\\_Authors\\_Kit.pdf](http://www.asee.org/conferences-and-events/conferences/annual-conference/2013/program-schedule/2013_Authors_Kit.pdf). I also encourage you to take advantage of our Mentoring Committee's Paper Review Service (see [http://depts.washington.edu/englib/eld/paper\\_review.php](http://depts.washington.edu/englib/eld/paper_review.php)).

Meanwhile, here is the list of proposed session topics for the 2013 program. Topics of interest include, but are not limited to:

- Trends in engineering publishing and scholarly communication including open-access initiatives and novel uses of institutional repositories; Promoting open access to engineering faculty and researchers.
- Defining the library's and librarians' role in supporting e-Science and data management initiatives: what does it take to be successful and are we prepared for the challenge? Role of engineering librarians in facilitating e-science and data curation; Training librarians for data management and curation services; Educating faculty about the importance of archiving and managing scientific data; Library data management services for small-scale research projects; Emerging standards for archiving and disseminating research data.
- Integration of information proficiencies with the engineering curricula: current practices and new opportunities; Information Literacy, Professional Skills, and Life-long Learning; Assessment of course-integrated library instruction; Librarian-faculty partnerships; Partnering with Business/Social Science/Humanities Librarians to assist Engineering Students.
- Defining user assistance in the virtual environment: supporting online courses, MOOCs, best practices for designing online instructional materials, emergence of social networks for research and use of mobile technologies; New tools and techniques for delivering tutorials, e.g. course management software, video tutorials, etc.
- Assessment practices for research and instruction services: from design and implementation to delivery and measuring impact, how do we know we are successful?
- Building collections for teaching and research: who decides what engineers need? Developments in e-book content, platforms and tools; Library support for e-book readers, e.g. Kindle, etc.; Patron-driven acquisition models; Collaborative collection development, e.g. university consortia, multi-campus coordination, etc.; Digital collections for engineers.

The slate of candidates will be presented in late February 2013 and the election held a few weeks later in March. ELD is a volunteer organization: We need YOU! Running for and serving as an ELD officer is a great way to get involved in ASEE and contribute to your professional community.

Election to Secretary-Treasurer is a four-year commitment. The ELD member elected in 2013 will assume office at the end of the annual conference in June in Atlanta and serve through the 2014 conference in Indianapolis. After the 2014 conference, the Secretary-Treasurer becomes the Program Chair, who will be responsible for planning the 2015 conference in Seattle. At the end of the 2015 conference the Program Chair becomes Chair and will serve until the 2016 conference in New Orleans. In the fourth year, the Chair becomes Past Chair/Chair of the Nominating Committee. The Secretary-Treasurer, Program Chair and Chair are members of the Executive Committee (EC) and the Extended Executive Committee (EEC). The Past Chair is a member of the EEC. Progression from office to office is annual and automatic.

The directorship is a two-year commitment. In the first year the Director organizes the ELD welcome reception. In year two the Director organizes the annual banquet. The person elected Director next spring will organize the welcome reception in 2014 in Indianapolis and the annual banquet in 2015 in Seattle.\* The Director is a member of the EC and the EEC during their entire term.

I am grateful to all my colleagues on the Extended Executive Committee and the 2011 Program Planning Committee for their advice, assistance and willingness to step in when I dropped the ball.

# ELD Discussion List Guidelines

## ASEE Engineering Libraries Division (ELD) e-mail discussion list guidelines

ELD supports two primary email discussion lists, ELDnet-l and ELD-L. The two lists have some traits and guidelines in common, while others differ.

### Differences

ELDnet-l has open subscription, with over 600 subscribers from all over the world. ELD-L subscription is available to ELD members only, and currently numbers roughly 250 subscribers.

ELDnet-l has open posting – even non-subscribers can post to the list. For ELD-L, only list subscribers can post to the list, and only from the email address under which they are subscribed.

ELDnet-l is subject-focused – every posting to the list should have some obvious connection to engineering libraries or librarians. ELD-L is member-focused – postings can cover any range of topics.

Because of its greater number of subscribers, ELDnet-l is generally a better choice for posting sci-tech position/vacancy announcements than is ELD-L.

### Commonalities

Both lists are moderated, so that only postings that meet these guidelines are passed along to each list's subscribers.

Given both lists' connection to ASEE/ELD, a not-for-profit organization, neither list allows advertisements from commercial entities, while both lists allow such ads from not-for-profits. Example: Elsevier/Wiley/Springer would not be allowed to post ads about new products to either list, while a similar ad from a not-for profit entity (IEEE/ASME/ASCE) would be allowed. While advertisements from commercial entities are not allowed, a simple announcement about a commercial entity's new product or service would be allowed. See the definitions section below for definitions of "advertisement" and "announcement" as they relate to these guidelines.

ELD supports copyright law and interlibrary loan guidelines and urges all of its members to do likewise. Therefore, subscribers may use both lists to request information on the availability of a needed item, but are not allowed to use either list to request such items. In addition, all such requests should use a subject line that conforms to the following format:

Needed – [type of material]

Examples: Needed – journal article, Needed – conference paper, Needed – technical report

In that way, subscribers may readily identify those postings by their subject lines alone. List subscribers needing other information should avoid using the word "Needed" as the first word of their posting's subject line.

### Definitions

Announcement = publisher offers a brief (2-3 sentence) blurb stating that X new product or service is now available (or will be as of a specific date) and to please contact Y person or go to Z Web page for more information concerning content, pricing, etc.

Advertisement = publisher offers a full information spread that has a basic product announcement plus potentially detailed info about content, pre- and post- publication pricing, reviews, etc. – similar to the content of print product advertisements and brochures that publishers send through the mail.
