Can we really be turning the page on 2012? My goodness, how fast a year can go by when there's so much going on. It can be difficult to take a moment to reflect and take stock of what we've accomplished. What better time to do so than when the semester (or quarter) is winding down before we launch headlong into a new year? I'm particularly pleased to see impacts ELD members are making that are being noticed by ASEE and beyond. Allow me to highlight a few here.

The Accreditation and Standards Committee, chaired by Dianne Mizzy, has made huge strides in recommending revisions to the established ABET information literacy criteria. These recommendations merited serious consideration by ABET to the point that Dianne was invited to discuss them at the ABET Engineering Accreditation Commission Criteria Committee meeting in Washington, DC this past July. These are still under review, but we hope to see their eventual adoption by ABET.

Due to prior ELD advocacy for DOI's to be incorporated into ASEE publications, we were recently contacted by ASEE Executive Director Norman Fortenberry to nominate a member for inclusion on an ad hoc committee on ASEE Publication Policy. Jon Jeffryes, chair of the Scholarly Communications Committee, volunteered to represent ELD on this group. We expect this committee to begin its work soon.

Finally, as Bev Watford announced at our Business Meeting in San Antonio, there will be a new PIC IV Best Paper Committee to review and nominate a PIC IV candidate for the ASEE Best Paper Award. Craig Beard, our Publications chair, has volunteered to be our first nominee to this Committee. We expect to hear if he will be added to the final committee roster early next year when paper reviews begin in earnest.

Speaking of Atlanta, Adriana Popescu and the Program Planning Committee have been hard at work getting ready for the Annual Conference. The program is coming together with some exciting developments! Please see Adriana's Program Chair update for more information.

# Conference Program Update

## Conference Program Update

Greetings from a rainy, foggy Princeton, NJ! While everybody is looking forward to the holidays, the Conference Planning Committee is working very hard to shape our division's program at ASEE 2013 in Atlanta. First, thank you to everyone who submitted an abstract, or suggested a panel session or a distinguished lecture for the program in Atlanta. Despite the fact that we only have 17 abstracts submitted this year, less than what we had last year, I am happy to report that it's beginning to look a lot like a great Conference!

This year ASEE has pre-assigned the number of technical sessions for each division, based on the division's historical data for abstracts submitted vs. papers published, over the past five years. So, we have two technical sessions and one poster session assigned, to include the papers of the 17 abstracts currently in draft paper stage. Overall, ELD will have 11 sessions, 2 less than last year, partly due to the pre-assigned number of technical sessions and the diminishing number of abstracts submitted for technical sessions.

Thanks to the hard work of the Scholarly Communications Committee, our request for a panel session on the topic of Open Data has been approved. The panel will explore ways that university libraries addressed the impact of National Science Foundation's data management plan requirement. The panel will look at roles librarians could play in assisting researchers with those plans, and more generally facilitating the process of making researchers' data more open. The speakers come from libraries at different stages of introducing research data support and will offer perspectives from different levels of involvement in data support services.

Our division has also submitted a proposal for a Distinguished Lecture, which has been also accepted by the PIC Chairs for the 2013 ASEE Annual Conference. Michael Carroll, Professor of Law and Director, Program on Information Justice and Intellectual Property, American University, Washington College of Law will present on "Open Access and Open Educational Resources: The Internet's Growing Role in Scientific Communication and Education". His lecture is scheduled for Wednesday, June 26, 2013 from 10:30 a.m. to Noon in the Georgia World Congress Center (GWCC). Professor Carroll (<http://www.wcl.american.edu/faculty/mcarroll/vcard.vcf>) is a leading advocate for open access to the research that appears in scholarly and scientific journals. He has written white papers and has given numerous presentations to university faculty, administrators, and staff around the country on this issue and we are very pleased that he accepted our nomination and sponsorship for a Distinguished Lecture at ASEE 2013. In response to our inter-divisional cooperation efforts, our proposal has been supported by the Graduate Studies Division.

Our Directors, Annie Rauh and Aleteia Greenwood have teamed up to work on the planning details for the ELD Banquet on Tuesday, June 12 and the Welcome Reception, on Monday, June 11. Given the positive feedback after last year's participation in the ASEE Mixer event, we will again have a presence at the mixer in Atlanta.

Other items to look forward to are the Lightning Talks, back by popular demand, and new for next year, a Hot Topics Round Table discussion, which will focus on topics related to collecting, selecting and maintaining e-book collections for engineering education.

While it may look like we will have a busy schedule, once again, there will be no early morning sessions, and there will still be time left for fun and play so look for updates from our dedicated CUEBALLS organizers as the Conference week gets closer. Nominations are an essential part of the awards process. The committee welcomes input from engineering librarians and other colleagues.

- Have you read an excellent engineering information related paper or book written in 2012?
- Have you been impressed by a new resource, service or tool that provides innovative access to engineering information?
- Do you know someone who deserves to be recognized for his or her "Distinguished Service" to ELD and/or engineering information?

If you answered "Yes!" to any of these questions, please take the time and effort to nominate each item for which you said "Yes"! Please feel free to nominate more than one worthy candidate. Receiving nominations and a wide variety of perspectives is extremely helpful to the Awards Committee as it goes about trying to determine "the best of the best".

**1. HOMER I. BERNHARDT DISTINGUISHED SERVICE AWARD** - Each year at the ASEE Annual Conference, the Engineering Libraries Division presents an award that recognizes work that contributes to the advancement and development of excellence in engineering libraries. Membership in ASEE is not a requirement for this award.

Award nominations must include the name, title, and contact information of the nominee and nominator, nomination rationale statement, and curriculum vitae of the nominee. The rationale statement should not exceed 700 words and should clearly indicate why the candidate is being nominated for this award. Letters of support from individuals besides the person making the nomination may be included.

**Deadline for Nomination: February 5, 2013.**

**2. BEST PUBLICATION AWARD** - The purpose of this award is to honor the best new paper or non-reference monographic work in engineering information published during the year 2012.

Criteria:

1. Single or multiple authors are eligible. Works authored by Awards Committee members are ineligible during the members' term of service.
2. Work must have been published during the year prior to the year in which the award will be made.
3. Work should represent a significant contribution to the field of engineering information. Work should be scholarly, show evidence of thorough research, documentation, and critical evaluation. It should be clearly written and well organized.

### 3. INNOVATION IN ACCESS TO ENGINEERING INFORMATION AWARD

The purpose of this award is to honor innovation in access to engineering information.

Criteria:

1. Awarded to a person or entity for the creation of a resource, service or tool in any format that provides innovation in accessing, utilizing, or presenting engineering information. Members of the Award Committee are ineligible during the members' term of service.
2. The resource, service or tool must have become available during the two years previous to the year in which the award will be made.
3. The resource, service or tool should represent a significant contribution to the field of engineering information.
4. Resources in all media are eligible.

**Deadline for Nomination: February 5, 2013.**

The ELD Awards web page ( <http://depts.washington.edu/englib/eld/awards.php> ) has this detailed information on each award as well as a listing of past recipients. A new feature of the page this year highlights the work and accomplishments of the Homer I Bernhardt Distinguished Service Award winners back to 2001. We have a rich history of remarkable accomplishments by ELD members!

Remember: your participation in the nomination process is essential to keeping the Awards a vital part of ELD. Without your nominations, we run the risk of missing the "best of the best!"

### Development Committee

ELD is very fortunate to have the support of two generous sponsors for the ASEE / ELD Atlanta 2013 Travel Stipends: Morgan & Claypool Publishers and Momentum Press. Details about the travel stipends, application process, and deadline are included in below. Take a moment to read the guidelines, and if inadequate funding has been a barrier to attending ASEE, please consider applying.

**ASEE / ELD Atlanta 2013 Travel Stipends**, sponsored by

**Morgan & Claypool Publishers** and **Momentum Press**

The leadership of the Engineering Libraries Division (ELD) realizes that the American Society for Engineering Education (ASEE) annual conference is an expensive event. Unlike some library conferences, where registration fees are less than \$250, the least expensive registration for the 2013 ASEE conference is \$580. In addition, airline and hotel prices continue to increase, while at the same time university travel budgets remain the same or decrease.

While the conference costs may be particularly problematic for librarians who are new to the profession or who are in entry-level or near entry-level positions, travel support varies greatly between universities. Therefore, a librarian at any career stage may find it difficult to attend the ASEE conference.

With that in mind, Morgan & Claypool Publishers and Momentum Press have agreed to sponsor travel stipends for the Atlanta conference. Morgan & Claypool has allocated \$1500 to be disbursed in two \$250 random drawing awards and two \$500 need-based awards. Momentum Press has allocated \$1,000 for a single need-based award.

The drawing for the two Morgan & Claypool \$250 awards was held at the ASEE San Antonio conference, with the following winners and alternates selected: Hema Ramachandran and Robyn Rosenberg as winners and Dianne Mizzy, Kari Kozak, and Elizabeth Cheney as alternates. The award will be sent to each recipient after confirmation of the recipient's registration for the Atlanta conference. If a recipient does not attend Atlanta 2013, the funds will be awarded to the alternates in the order that they were drawn.

We are now ready to accept applications for the three need-based awards. They are as follows:

Morgan & Claypool early career travel stipend of \$500 – Librarians who are in their first five years of professional appointment are eligible for this.

Morgan & Claypool open librarian travel stipend of \$500 – Librarians at any stage of their career are eligible for this.

Momentum Press early career travel stipend of \$1000 – Librarians who are in their first five years of professional appointment are eligible for this.

Any librarian who is an active member of ELD as of January 25, 2013, may apply for the travel stipend. Applicants must supply all requested information in the Web form available at <http://gemini.lib.purdue.edu/ELDgas/travel-appl.cfm>. This funding is meant to support those with the greatest need, so applicants will be asked to document what level of funding they can expect to receive from their institutions, travel information, and career information to determine eligibility.

A panel of current and former ELD officers will review the applications and determine the awardees. The entire pool of applicants will be listed according to need, regardless of their career stage, and awards will be granted according to eligibility. The first listed early career applicant will receive the Momentum Press \$1,000 stipend. The second listed early career applicant will receive the \$500 Morgan & Claypool stipend. The \$500 Morgan & Claypool open award will be given to the first librarian on the list who has not yet received an award.

In the event that an award recipient cannot attend, the awards will be adjusted. For instance, if the Momentum Press recipient cannot attend, then the early career Morgan & Claypool recipient will be given the \$1000 stipend, and the next early career librarian on the list will receive the \$500 award.

The travel stipend website will open on December 7, 2012. Applications MUST be received no later than 5 PM EST on January 25, 2013. The travel stipend panel will determine the stipend recipients, and awardees will be notified no later than February 15th. Awardees must send confirmation of ASEE registration to ELD Secretary/Treasurer Megan Sapp Nelson, [mrsapp@purdue.edu](mailto:mrsapp@purdue.edu), no later than March 15th. Checks will be sent to awardees when confirmation of conference registration has been received. If registration confirmation is not received by March 15th, the stipend will be given to the next eligible person on the need-based list. Adherence to this timeline is necessary so that awardees and alternates will know whether they will receive awards before the ASEE conference early-bird registration deadline, which is April 1.

Awards may be used ONLY to support attendance at ASEE 2013 in Atlanta. In the event that an ELD member is awarded a stipend and does not attend the ASEE conference, the member agrees to reimburse ELD for the stipend amount.

In the event that the travel stipends are offered in succeeding years, winners are ineligible to receive an award for two years following receipt of an award (e.g. the winner of an award for Atlanta 2013 is ineligible for an award in Indianapolis 2014 and Seattle 2015).
