Program Chair's Update

I would like to thank everybody that stepped forward and submitted an abstract for either a technical paper or a poster for the 2010 ASEE Annual Conference in Louisville, June 20-23. Also, big thanks to those of you that are working on putting together panel presentations as well.



We received 20 abstracts (down from previous years) but received three panel discussion ideas with which we are moving forward. We will also be co-sponsoring a session with the New Engineering Educators (NEE) Division. For those of you hard at work on your papers, please be reminded that the Mentoring Committee offers a [Paper Review Service](#) on the ELD website:

A total of 14 sessions were requested and I am happy to say that all 14 were accepted. These include 5 technical sessions, 3 panel discussion sessions, 1 poster session, 3 business sessions, and 2 social sessions. Some of the technical and panel session topics changed from those that were originally suggested back in Austin, as I was warned they might be by previous Program Chairs, but I think that we've got what is shaping up to be another inspiring set of technical sessions and panel presentations. Awards Committee "Call for Nominations"

The ELD Awards Committee is seeking nominations for three annual awards. (The fourth award - Best Poster - is decided at the Annual Conference and Exposition in June, 2010.) Nominations are an essential part of the awards process. The committee welcomes input from engineering librarians and other colleagues.

Ask yourself the following:

- Did you write an engineering information related paper/book in 2009?
- Have you read an excellent engineering information related paper/book written in 2009?
- Have you purchased or reviewed a significant engineering information related reference work written in 2008 or 2009?
- Do you know someone who deserves to be recognized for his or her "Distinguished Service" to ELD and/or engineering information?

If you answered "Yes!" to any of these questions, please take the time and effort to nominate each item you said "Yes!" too. Please feel free to nominate more than one worthy candidate. Nominations and opinions regarding reference works are particularly sought by the committee since none of us owns everything published!

Please take note of the February deadlines. ASEE has deadlines in early March that the committee must meet, so the decision making process the committee goes through must allow adequate time.

1. HOMER I. BERNHARDT DISTINGUISHED SERVICE AWARD - Each year at the ASEE Annual Conference, the Engineering Libraries Division presents an award, consisting of a plaque that recognizes work that contributes to the advancement and development of excellence in engineering libraries. Membership in ASEE is not a requirement for this award.

Award nominations must include the name, title, and contact information of the nominee and nominator, nomination rationale statement, and curriculum vitae of the nominee. The rationale statement should not exceed 700 words and should clearly indicate why the candidate is being nominated for this award. Letters of support from individuals besides the person making the nomination may be included.

2. BEST PUBLICATION AWARD - The purpose of this award is to honor the best new paper or non-reference monographic work in engineering information published during the year 2009.

Criteria:

- Single or multiple authors are eligible. Works authored by Awards Committee members are ineligible during the members' term of service.
- Work must have been published during the year prior to the year in which the award will be made.
- Work should represent a significant contribution to the field of engineering information. Work should be scholarly, show evidence of thorough research, documentation, and critical evaluation. It should be clearly written and well organized.

Deadline for Nomination: February 5, 2010

3. BEST REFERENCE WORK AWARD - The purpose of this award is to honor the best new reference work in engineering information.

Criteria:

- Single or multiple authors are eligible. Works authored by Awards Committee members are ineligible during the members' term of service.
- Reference works must have been published/released during the previous two years prior to the year in which the award will be made.
- Reference works should represent a significant contribution to the field of engineering information.
- Works in all media are eligible.



Deadline for Nomination: February 5, 2010

Remember! Your participation in the nomination process is essential to keeping the Awards a vital part of ELD. Without your nominations, we run the risk of missing the "Best of the Best!"

Home Sweet Home; the permanent ELD Archives

Don Richardson suggested to the Engineering Libraries Division Executive Committee that I be appointed to replace him as the division's archivist. There were probably two reasons for his suggestion; I had been a member longer than most of the other members of the division and our libraries are an hour and a half drive apart. It would be easy for me to pick up the cardboard boxes and save the division the cost of shipping. I accepted only on the condition that Cecilia Mullen, another long time member and former archivist, serve with me.

Once at UMass Dartmouth the archives lived in a filing cabinet in a conference room for several years. During that time I considered how to find a permanent home for them. This consideration was based on the thought that my successor might not be so conveniently located.

Three years ago, this library, under the directorship of former ASEE ELD member Ann Montgomery Smith, received sizable gifts from our local Portuguese community for the enlargement and renovation of our library Archives. I asked Ann and our Archivist, Judy Farrar, if it would be possible to add the ASEE ELD archives to the collection and maintain the archives for the ASEE ELD archivist regardless of where that archivist was located. Ann and Judy agreed. The vote on the deed of gift took place at the division's annual business meeting.

This article marks the "official" opening of the ASEE permanent Archives.

Report to EDL on American Chemical Society meeting held in Washington D.C. in mid-August 2009 (Fall Meeting)

I have been an ACS member for almost 50 years, but this was my first ACS meeting in the last 15 years since I had been working in the Computer Science area before moving to The College of New Jersey. So I was in for quite a cultural shock, since the composition of the attendees had changed from white males in suits, with a few females such as me who were mostly in the literature areas, to approximately 50/50 males/females with many different cultural backgrounds. However, I found that the Chemical Information Division, in which I was presenting a paper, had not changed as drastically and I was able to re-connect with many old friends.

The individual sessions were very interesting and consisted of either general topic discussions which could have been applicable to any scientific discipline or reviews of new databases which were of interest only to those in specialized segments of the chemical industry. Again in contrast to ACS meetings of old where only Chemical Abstracts Service held the spotlight on databases, many, often free, specialized services were discussed which in many ways compliment the CAS databases. It appears trite to say it but the sources of chemical information, like other information sources, are growing exponentially and I wish I had more time to spend at the meeting and learn even more.

The general topics such as the symposium at which I spoke, "Federated Searching, Beyond Traditional Abstracting and Indexing Services," highlighted much of the same problems librarians face in other disciplines, such as engineering. Are the traditional fee-based services being replaced by free algorithm-based databases such as Google Scholar?
