So what is ELD's agenda for this year? One important issue is funding. At our annual business meeting in Edmonton we had a lengthy discussion on how to increase our revenues to help offset the increasing costs of both the paper (e.g. our Newsletter and Membership Directory) and electronic services (e.g. ELDNET-L) which we provide our membership as well as the increasing costs associated with expenses related to the annual conference (e.g. computers, phone lines, overhead projectors). Without dissent a motion was passed to bring to the membership this year a vote to increase our division dues from \$1 to \$5. Although it may appear that a jump from \$1 to \$5 is large the overwhelming feeling at the business meeting was that \$5 is a relatively modest sum, that it was in-line with what other divisions in ASEE charge for membership, and that, most importantly, it would provide us with the flexibility to improve the services we provide to our membership. I hope you agree. Sometime in the next few months I will be distributing the ballot to the membership in both printed and electronic form. A simple majority of those voting is needed to pass this dues increase.

I am also in discussion with ASEE Headquarters to determine whether there might be a possibility to raise money for ELD by selling our mailing list to interested parties. In doing so we would want to insure that the privacy of our membership is considered. However, requests for our mailing list are infrequent and not likely to provide a major source of revenue even if we can negotiate an agreement with Headquarters that is satisfactory.

Other initiatives for this year include establishing a home page on the World-Wide-Web for ELD. Jim Ottaviani of the University of Michigan, John Saylor from Cornell, and the Electronic Publications Subcommittee of the Publications Committee all expressed interest in this project, and they will be working together to make it a reality. And the Accreditation and Standards Committee will be continuing its work to develop a database of comparable statistics for engineering type collections and services.

I would also like to share let with you the letter I was charged to send **Hal Wiren**, retired engineering librarian at the University of Washington and former ELD Chair, by a motion passed unanimously at our annual business meeting, and part of Hal's response:

In accordance with a unanimous resolution passed at the recently completed business meeting of the Engineering Libraries Division at the ASEE Annual Conference in Edmonton, it is my pleasure to write you in acknowledgement and thanks for your recent letter to the editor which appeared in the May 1994 issue of ASEE *Prism.* Your eloquent articulation of the importance of information retrieval skills for engineering students and the role of professional librarians in developing and teaching those skills is appreciated by all of us who are in the business of providing information resources to engineering students, educators, and practitioners. Even in retirement, Hal, you continue to play a leadership role for engineering librarians. Again, thank you for your continuing efforts.

Once in that subdirectory, if you FTPed to the initial address, you may use the GET command to retrieve any of the files available.

If you TELNETed to the initial address, you'll now have to FTP the files to your address. If you have any questions about what your local file transfer capabilities are, please contact your systems librarian or someone in your local computer center for assistance.

The date in the top left corner of the file indicates when the file was last updated. Both the Resource Guide and the Membership Directory will be updated this fall.

Minutes of the 1994 Annual Business Meeting

Meeting Begins 4:45 PM 6/28/94

I) Approval of 1993 Business Meeting Minutes: Passed without dissent.

II) Annual Reports (Updates from reports provided in May 1994 Newsletter)

A) Archivist: Nothing to add

B) Awards: Nothing to add

C) Duplicates: Nothing to add

D) Membership: Glee Willis reported that the University of Edmonton Library would be open for visits, but that no formal tours would be held.

E) Membership Directory: Jim Van Fleet announced that the new directory would be out in October.

F) Publications: Tom Conkling announced that we had sold 442 copies of reports as of May 31 with the Union List of Serials accounting for 227 of those. He urged members to volunteer for openings on the union list and literature guides subcommittees as well as for the post of newsletter editor.

G) Listserv: Mel DeSart indicated that the Listserv would be moving to the University of Kansas in early July. Subscriptions are over 300!

H) Standards: Karen Andrews has some of the results of the survey; she asked members to send in results if they have not already done so.

I) Discussion of Reports:

1) There was a discussion of how to get list of ELD publications and the role ASEE has in promoting them.

2) All reports were accepted without dissent.

III) Discussion of Electronic Publications Subcommittee: This subcommittee suggested the idea of establishing an ELD Mosaic home page. As Jim Ottaviani and John Saylor were also interested in working toward this goal, it was suggested that all interested parties collaborate on development of a WWW resource.

IV) Election of New Officers: The following passage was placed in the minutes by Paige Gibbs, Chair of the Nominating Committee:

"I wish to thank Karen Andrews and Kate Herzog for their excellent work as members of the nominating committee." The nominations committee recommends as candidates for the division offices:

As is our practice, the outgoing Secretary/Treasurer cast a vote to confirm the slate at the unanimous urging of the membership.

V) Cecilia Mullen made the motion that all outgoing officers and committee chairs revise their job descriptions and send them to the Listserv manager by August 15. Position descriptions would be posted for comment between September 1 and 15. The motion was passed without dissent.

VI) Operating Expenses: Cecilia Mullen has requested an increase in the operating budget to cover costs that are now being absorbed by the members.

VII) Fundraising: In order to cover the increasing costs associated with membership outreach and conferences, ELD is considering a variety of ways to bring in extra funding. A generous gift of \$500 from Engineering Information this year was noted. In order to raise funds, the idea of selling the membership list to commercial concerns was raised. ASEE charges \$90 for a mailing list; money would be made by asking for a donation for some amount in excess of \$90. Concerns included the the question of whether the lists could be resold (no) and whether members could withhold their names from distribution (no). The issue was raised that by selling mailing lists we would be infringing the privacy of members without offering them an opportunity not to participate. A motion to sell the ELD mailing list for \$250 without fax numbers or e-mail addresses was made and seconded. A friendly amendment to ask ASEE to remove the names of those unwilling to participate in the marketing of mailing lists was accepted. A proposed amendment to increase the fee to \$500 was voted down on a vote of 16 yes, 19 no and 3 abstentions. The amended motion of selling mailing lists for \$250 without fax numbers or e-mail addresses after asking ASEE to remove the names of those unwilling to participate in the marketing of the list was approved by a vote of 36 yes, 1 no, 1 abstention. A motion to have the executive committee vote to approve each proposed sale of the list was approved without dissent. Glee Willis volunteered to solicit the names of individuals who do not want their names sold as part of the ELD mailing list.

VIII) The Making of an Engineer: Paige Gibbs placed the following motion before the membership: I move that the incoming Division Chair be directed, on the behalf of the membership, to send a letter of commendation and appreciation to Hal Wiren for his strong support of Engineering Libraries and their importance to the education of engineers as expressed in his letter printed in the May 1994 *Prism* titled, "The Making of an Engineer." The motion passed without dissent.

IX) Dues Increase: Pointing out the increased costs of paper and electronic services to the membership at large and of the expenses related to the annual conference. proponents of a dues increase pointed out that the \$1 per year divisional fees are much lower than other library organizations and ASEE divisions. Steve Gass discussed the idea of an increase to \$5 per year and heard from ASEE that a simple majority of paper ballots to the membership could affect the change. Cecilia Mullen suggested that we press ASEE to increase our divisional funding before raising dues, but other speakers, citing a number of embarrassing incidents associated with our divisional poverty and the very low current fee, strongly urged the fee increase ... some even suggesting a higher figure. The motion to put the question of a dues increase to \$5 per year before the entire membership passed without dissent.

X) The theme of next year's meeting: Engineering Education: Investing in the Future was announced. Bob Schwarzwalder, incoming Program Chair, urged anyone interested in participating as a speaker or moderator to contact him.

XI) The meeting was adjourned at 6:15 PM.

News from Linda Hall

The Linda Hall Library in Kansas City has had a very busy year. **C. Lee Jones** shares the following with us.

The Linda Hall Library expects to have the Transfer Agreement (transferring ownership of the Engineering Societies Library, ESL, collection to Linda Hall) approved by late summer or early fall. The Linda Hall will immediately begin shipping materials that are being selected for transfer. But there will be a substantial amount of material that is not selected by the Linda Hall because of duplication in the LHL collection or, more rarely, out of scope materials. Step two in the process of distribution of the ESL materials will be an opportunity for the five founding societies to select materials in which they may have an interest. There will still be a substantial amount of material that will be available for any libraries wishing to make selections.

There will be some rules for this selection. There will be no bibliographic guides prepared. So, if an institution is interested in making selections, it will have to send someone to the ESL site to do the selection. Selecting institutions will be responsible for moving selected materials out of the ESL site within 60 days after selections are complete. Institutions will be asked to note that the source of selected items was the ESL in their bibliographic records and/or ownership plating.

Since we do not have a precise date when the LHL selection and transfers can begin, we do not know when interested institutions might have the opportunity to make selections. But we believe that this selection window will be this winter or very early spring, Clearly, all costs of selection and shipping must be borne by the participating institutions, including travel, lodging, packing, shipping, and any miscellaneous costs.

While this is rather like a grab bag situation, the Linda Hall Library would like to know which (if any) institutions would like to make selections from the ESL collection remainders.
