# **Approval of 2014 Minutes**

The minutes from the 2014 business meeting were distributed for approval. Rick Olson made a motion to approve the minutes, with those corrections. Ed Pohl seconded the motion. The minutes, with corrections, were approved unanimously.

## PIC I Chair Report -Adrienne Minerick

#### • ABET Outcomes

- o ABET open comment period on #3 and #5 criteria ends 7/1/15. The changes are available for review on the ABET website.
- o ASEE members are asked to review and comment
- o Review is requested of all technical societies.
- o Minerick, chair of ASEE Diversity Committee, suggested adding a comment to add a diversity statement to the outcomes.

#### • ASEE Conference Sessions

- o Organizing a special session/panel will be possible in the future
- o Special session/panel will not have to be tied to papers
- o Special session/panel request will be due 10/31/15

#### Finances

- o ASEE is running a 5 year deficit
- Conference and membership fees are not being raised at this time. The
  conference is a revenue generator for the society. Dean's conference loses
  money.
- o 60% overhead charges or admin fees charged to funds coming into divisions' BASS accounts will pay for 1 full time accountant with benefits. This was changed at the Board meeting during the conference to 30%. Each division was asked to consider a by-laws change to increase dues to offset the 30% loss by August 31 for approval by the ASEE Board in time to implement the change for the October billing cycle.
- o Grants and contracts now have to have cost neutral staffing.
- Each division is requested to have one person assigned to consolidate all disbursements and submit at one time for reimbursement
- o Institutional membership fees are being raised in order to generate \$750,000 in revenues.
- Not clear on whether ticket sales (awards banquet, etc.) are accrued to BASS accounts.
- o Any internal movement of endowed account monies will not be "taxed".

# • Special Project Funds

- ASEE is willing to award divisions up to \$500 for projects designed to increase membership. Matching funds from the division are required. This could be used for travel for panelists.
- o Applications are due by September.
- o This is a competitive fund that requires well thought out proposals.
- Division Feedback
- PIC 1 Best paper
  - o Paper on flipped classroom originated from ChE Division
  - The ChE division was the PIC 1 chair's "home" division.

- Best Diversity paper
  - o There were 25 nominations for best diversity paper
  - o Top 6 were presented in a special session.
- Questions for Adrienne
  - Jane asked how does ASEE justify its diversity position with international accreditations in areas were diversity may not be recognized. Minerick acknowledged a certain level of "cognitive" diversity being applied.
  - Larry asked about the statement in the 2014 IED minutes quoting Minerick as stating the Society was "in the black". Minerick denied making the statement and pointed out that this would be true only if legal fees were not accrued properly.
  - Tish pointed out that electronic voting was acceptable under IED's current bylaws relative to restructuring division dues.

## <u>Program Chair Report</u> – Leonardo Bedoya-Valencia

Leonardo presented an account of this year's program from IED

- 32 Abstracts were submitted
- 21 draft papers received
- 14 papers were accepted
- 32 reviewers completed reviews mostly on time. Leonardo complimented the reviewers.
- 1 paper transferred to SED
- The remainder were rejected as having nothing to do with education and should have been in the IIE conference.

Jane indicated that the number of technical sessions was right. It was pointed out that an additional technical session can be acquired when the division has 48 submitted abstracts. In the interim, extra papers will be rolled into poster session. There was a general discussion on working with other divisions to increase the abstract count.

There will be no paper fee as long as the conference generates a positive cash flow.

# Financial Report - Gene Dixon

As of the conference, the known balance of the IED accounts are:

```
Ending BASS account balance = $21,936.86 (2014 - $21900.27)
Operating account balance = $282 (2014 - 266.00)
```

There have been no journal entries for the last 9 months due to the ongoing audit of ASEE accounting. The accounting staff at ASEE has experienced significant turnover of employees. ASEE is currently reporting \$1.2M in liabilities.

Rick asked how ASEE is handling disbursements. Joe, having had discussions with ASEE's financial representative at the conference, indicated that ASEE has a stack of receipts and will pay expenses in order of receipt. It was reinforced that ASEE is

requesting one person compile disbursement requests, receive the money personally and pay individuals from the proceeds.

It appears at this time that the BASS account funds are "safe" for now.

# <u>Old Business – Leonardo Bedoya-Valencia</u>

Leonardo reviewed issues surrounding our current IED awards.

- There was general discussion concerning a New Educator Award. It appears not enough new IE faculty are being generated and Larry suggested making this award every 2 years for \$1000 vice every year for \$500. Publicizing this opportunity may garner applicants.
- Justin suggested a travel award to encourage new faculty to attend the conference.
- There was general discussion regarding renaming IE Division Best Paper Award to Outstanding Paper Award.
- The bylaws were last reviewed in 2010.
- Motion made and carried to add a diversity statement to the bylaws based on ASEE's boilerplate. A recommendation was made for Eric Specking to represent IED on ASEE's Diversity Committee (See Installation of New Officers below).

## PIC 1 Meeting on Sunday

- ASEE is growing. PIC 1 is not growing. What can be done?
  - According to the Campus Representatives meeting there is no limit on the number of divisions a member can join.
  - o Recruit IED members
  - o Hold a big party at the division mixer with raffles, door prizes, etc.

# <u>Installation of New Officers – Leonardo Bedoya-Valencia</u>

Because the Bylaws provide for orderly transition of officers, only a new Secretary/Treasurer needed to be elected. Just one candidate was proposed for the position: Justin Kile from the Quinnipiac University. Justin was elected by acclamation.
