 - ASEE Annual Meeting Demographics
 - > 307 Social and business sessions
 - > 328 Technical sessions
 - > 1683 Papers, 58.6% published from abstracts
 - > ASEE membership is 11,500. This is down from the 2008 peak, which was between 12,000 and 13,000.
 - Multidisciplinary Division Membership
 - > 1295 members, which is an all-time high
 - > 2nd largest division
 - > 29% of the division is female
 - Future Directions
 - > Consider adding to the next Call for Papers a request for presentations related to the topic of vertically integrated multidisciplinary student projects (special session)
 - > The theme for the 2016/17 Annual Conference is "Commit to P12"
 - Best paper award presentation
 - ➤ The Best Multidisciplinary Division paper award of 2016 was presented to Forbes, Sullivan, Myers, and Reamon, "Exploring Student Impressions of and Navigations through a Flexible and Customizable Multidisciplinary
