- 2. Business Meeting Minutes from June 27, 2016 were distributed and approved.
- 3. Welcome from the Division Chair, Gayle Ermer
- 4. Chair Report Gayle Ermer
 - ASEE Annual Meeting Demographics
 - ➢ 337 Business, Social, and Panel Sessions
 - ➤ 322 Technical sessions
 - > 1606 Papers, 57.4% published from abstracts
 - ➤ ASEE membership is 11,174
 - Multidisciplinary Division membership is 1362 members, an all-time high
 - Update on Division By-Laws
 - Recent changes to by-laws that have been approved by the division include:
 - Revised office duties to reflect current division practices
 - Added diversity language
 - The changes to the by-laws were submitted to PIC II chair, Marjan Eggermont, who reported that the changes were approved by the Board on Sunday, June 25, 2017
 - A website manager is needed to transition/update our old website to the new ASEE mandated format
 - Dennis Silage volunteered to take on this role
 - It was noted that some of the more recent meeting minutes may not be on the old site and will need to be posted to the new site
 - Future Directions
 - Gayle Ermer facilitated a discussion with those present to identify possible future directions for the division. The following items were discussed:
 - Continue to allow Work-in-Progress (WIP) papers as a means for members to get feedback on preliminary work. For WIP papers there needs to be a clear indication if the paper is a WIP or full-paper to

avoid confusion for reviewers. Perhaps in the call for papers, require the title of these papers to begin with "Work in Progress:" It was suggested that WIP papers be scheduled into a separate session rather than including them in with full-papers of a similar topic.

- Consider hosting lightning talks or speed networking
- Consider separating the business meeting from a social event to allow members more time to interact
- Potential topics for sessions:
 - Discuss "What's in a Name?" to discuss what we mean by multidisciplinary/interdisciplinary; what do employers expect, what do we call this type of degree
 - Impact of new ABET criteria on General Engineering Programs
- 5. Program Chair Report Jean Kampe
 - Summary of ASEE 2017 Multi Program
 - Number of submitted and transferred abstracts: 68 (60 accepted, 4 rejected, 2 withdrawn before review, 17 did not submit paper)
 - Number of submitted papers: 43 (1 rejected, 1 withdrawn, 0 transferred in after review)
 - Papers accepted and placed in sessions 40 (10 approved on draft, 31 moved to rewrites, 1 rewrite not submitted) [last year 31, previous year 36]
 - ▶ 58.8% published from abstracts submitted
 - Multidisciplinary program/sessions:
 - 9 technical sessions sponsored solely by Multidisciplinary Engineering [8 last year; 8 previous year] with 40 papers
 - 1 panel session [W341] sponsored solely by Multidisciplinary Engineering
 - Co-sponsored [M445] panel, "P-12 STEM Education: Learning through Guided Discovery" with Eng. Physics and Physics Division (lead) and other divisions
 - Co-sponsored [M448A] panel, "Perspectives on Systems Engineering's Critical Role in Transforming Engineering Education Around the Globe" with Systems Engineering Division
 - Multi was a co-sponsor for the "Interdivisional Town Hall Meeting: The Culture of Teaching" [M534A]
 - Last year when an abstract was recommended for transfer to another division, it was discovered that some people were submitting abstracts to multiple divisions (the paper had already been submitted to that division). It appears that the author(s) were submitting their work to multiple divisions to improve their chances of being accepted.
 - Best paper award presentation
 - The Best Multidisciplinary Division paper award of 2017 was presented to Watson and Barrella, "A Systematic Review of Sustainability Assessments in

ASEE Proceedings." Dr. Mary Katherine Watson of The Citadel and Dr. Elise Marie Barrella of James Madison University accepted the award.
