

MINUTES OF THE  
THIRTY-NINTH ANNUAL MEETING  
OF THE SOUTHEASTERN SECTION  
of the  
AMERICAN SOCIETY FOR ENGINEERING EDUCATION  
April 11, 12, & 13, 1973

The thirty-ninth annual meeting of the Southeastern Section of the American Society for Engineering Education was held on April 11, 12, and 13, in Athens, Georgia, with the University of Georgia serving as host. The published list of registrants indicated an attendance of 225 men and 45 ladies.

At the opening session, President Robert E. Uhrig presided and called the 39th annual meeting to order.

Dr. Fred C. Davison, President, University of Georgia welcomed the group to the University of Georgia campus. Dr. Robert H. Brown, Chairman of the Division of Agricultural Engineering welcomed the group to the campus and invited the members to visit the Agricultural Engineering Building. Dr. Brown announced that all classes and laboratories would be open between 2:00 and 4:00 p.m., Friday, April 13, 1973.

President Uhrig introduced Dr. Joseph M. Pettit, ASEE President and President of Georgia Institute of Technology, as keynote speaker. Dr. Pettit's talk was entitled "The Organization, American Society for Engineering Education". He stressed the need to reach the non-member on the engineering faculty; establishment and disestablishment of divisions; work of the projects board; the Journal and other landmark projects.

At the Annual Banquet, Dr. Robert H. Brown, University of Georgia gave the invocation. President Uhrig presented the Dow Outstanding Young Faculty Award to Larry Hench, University of Florida. Vice President Chalmers M. Butler, University of Mississippi, Chairman of the Research Unit presented the Annual Southeastern Section Research Award to Donald G. Childers, University of Florida for his paper "Spatio-temporal Measures of Cortical Functioning in Normal and Abnormal Vision" (Computers and Biomedical Research). Dr. Butler announced that the first runner-up was Dr. James M. Fields, East Tennessee State University and the second runner-up was Dr. James M. Fields, University of Kentucky.

President Uhrig thanked the Dow Chemical Co. and Western Electric Co. for making their awards to the Section.

Entertainment following the banquet was introduced by Dr. Wilbur Ratterree, Chairman of the Host Committee. The Athens Choral Society under the direction of Dr. Daniel T. Politoske, Assistant Professor of Music, University of Georgia, presented a delightful program of light and classical music. Jane Douglas was piano accompanist and Albert Ligotti, Calvin Hasbrouck and Benny DuBose accompanied on trumpet.

Dean J. Seay Brown, Tennessee Tech. and Chairman of the Place of Meeting Committee presented the following report which was unanimously approved:


1. Confirms the place of meeting for 1974 as Cookeville, Tennessee, with Tennessee Technological University as host.
